Signatory Authorization for Sidewalk Project and U.S. Cellular Lease Council Member Haskins motioned to hold separate votes for signatory authorization for the sidewalk project and the U.S. Cellular Lease. Council Member Haskins motioned to authorize Mayor Walker to sign documents associated with the VDOT Sidewalk Project. The motion was seconded by Council Member Jones and carried by voice vote: 4 ayes, 0 nays. 8 y consensus the vote for signatory authorization for the U.S. Cellular lease was postponed.

Committee Reports <u>Water Committee</u> – Council Member Jones stated that he is stepping down as chair of the water committee. <u>Personnel Committee</u> – Council Member Andrews stated that the Personnel Committee re-interviewed Stephen Hatcher. She then motioned to recommend that he be hired by the Town to train for the water operator position. The motion was seconded by Council Member Haskins and carried by voice vote: 4 ayes, 0 nays. <u>Building, Grounds, Streets & Lights Committee</u> – Council Member Andrews stated that the Tree Lighting went well and she wished to publicly extend thanks to the volunteer fire department for their assistance.

Water / Maintenance Report Dawn Watson stated that the new water operator trainee seems promising. She stated that electrical repairs were needed for the timer and garage door at well #7. She stated that the SCADA radio system was still not functioning properly.

Clerk's Karen Price reported that the FY 16-17 audit was underway. She stated that the insurance claim with the Virginia Municipal League was still not resolved. Karen reported that Town taxes were being prepared and would hopefully be completed by the end of the month.
